reasonable terms and for reasonable amounts subject to the approval of the President or a Vice-President. The GIC term shall not be for a period which exceeds one year without

the approval of the Board.

Judicial Independence – Financial Security Sub-committee

Judicial Independence Committee -Financial Security

Motion:

WHEREAS:

- (a) the Nova Scotia litigation was of national importance;
- (b) the judicial complement of the Nova Scotia Bench is relatively small;
- (c) the total cost of that litigation to the Nova Scotia Provincial Judges Association exceeded \$410,00, it being reasonably anticipated that after recovery of all party/party costs its net cost of the litigation will be in excess of \$360,000;
- (d) the Nova Scotia Provincial Judges Association is liable in the sum of \$210,000 to several judges' associations, including to CAPCJ in the sum of \$75,000, as loans to support that litigation;

BE IT RESOLVED that CAPCJ forgive the outstanding loan in the sum of \$75,000 to the Nova Scotia Provincial Judges Association.

Motion:

WHEREAS:

- (a) the members of the Judicial Independence Committee Financial Security unanimously consider it beneficial in advancing the aims and objectives of that committee, that inperson meetings on a semi-annual basis, rather than only its annual in-person meeting in conjunction with CAPCJ's Annual General Meeting is desirable; and
- (b) the added cost of a second meeting to CAPCJ is only the cost of two hotel rooms, the rental of a meeting room and breakfast, lunch and two mid-meeting breaks;

BE IT RESOLVED that henceforth, commencing in 2023, the Judicial Independence Committee – Financial Security be authorized to meet semi-annually in-person in conjunction with the Spring and Fall Board of Directors Meetings.

Motion:

WHEREAS:

(a) the members of the Judicial Independence Committee – Financial Security unanimously are of the view that it would improve the status, prestige and esteem of provincial/territorial courts across Canada if appeals from all decisions of those courts went directly to the Courts of Appeal of those provinces/territories rather than in the case of summary conviction appeals to what is another trial court of a justice sitting alone;

(b) an increase in prestige, status and esteem as recognized by Parliament is a useful consideration by Judicial Compensation Commissions/ Tribunals/Committees in increasing judicial compensation.

BE IT RESOLVED that the CAPCJ Committee on the Law be tasked with considering whether it should ask the Uniform Law Commission to recommend that appeals in summary conviction matters be directly to the provincial/territorial Courts of Appeal.

There was much discussion. The directors felt this was needlessly bureaucratic. There should be no barrier to what might be a good idea being sent to any committee directly. The director's did not what to create a precedent.

Judicial Independence - Security of Tenure and Institutional Independence Sub-committee

Motion: That the Judicial Independence - Security of Tenure and Institutional Independence - Sub-committee Report: Courthouse Security – Best practices be approved and uploaded to the website.

The directors agreed to **defer** the motion to the Spring meetings

NEC Motion

Motion:

That the National Education Committee be authorized to commence discussions with the Education Committee of CCCJ to develop an education strategy which ensures the delivery of judicial education in core competencies for all Provincial and Territorial Court judges.

Moved: Karen Ruddy: 2nd: Christine Lowe Passed

The discussion addressed the impetus behind this initiative being the concern about ensuring education continued to be available to Provincial and Territorial Courts. The director's felt that this motion provides the authority to talk to the Chief's.

Wellness and Conditions of Service Committee

Motion: That the Purposes and Goals of Wellness and Conditions of Service Committee prepared by Judge Theodore Tax be approved.

Moved: Karen Ruddy, 2nd: Andrea Chrenek Passed

The directors expressed a concern that there was some duplication of the Judge's Counselling Program. More importantly, they felt that this does not address the underlying systemic problems or ways to address the institutional issues that contributed to problems. The directors wanted to send it back for a re-write after consultation by the President with the Director's representative, Michelle Marquette, to ensure original motion's intent is addressed.

Constitutional Amendments

The directors expressed concern over the wording of the amendments generally. They identified a need to address apparent conflicts between the French and English versions. After a very lengthy discussion, while recognizing the valuable work of the committee to date, the consensus of the directors was that the document is not ready.
